By signing below, you agree to all of the following terms and conditions pursuant to which Prime Soccer Academy, an Ontario business shall provide. These terms and conditions apply to the Prime Soccer Academy named on the Registration Form. By execution of this Participant Agreement, you are acknowledging limiting terms and All prices are in Canadian Dollars.

Client Cancellation & Refund Policy

If you choose to cancel your reservation, we must receive written notice of said cancellation to primesocceracademy@gmail.com and you shall be subject to the following cancellation fee schedule: If we receive a written notice prior 30 days of the starting date, Prime Soccer Academy will retain \$100 as a compensation for the registration expenses. If we receive a written notice of cancellation within 15 days of the date, there will be no refunds of the amount paid for the Prime Soccer Academy. If the participant simply does not show up to the academy, there will be no refunds for the amount paid to the participant.

Cancellation Policy

We may cancel any Prime Soccer Academy session at any time for any reason. We will make commercially reasonable efforts to keep the schedule as it has been published; however, the final schedule may vary due to factors beyond our control. We may in our sole discretion substitute services or goods of similar quality for any service or good stated in the schedule. If a Prime Soccer Academy session is canceled we will not be liable for any other costs, damages, or refunds of any kind for any loss, delay, inconvenience, disappointment, or expense whatsoever in such circumstances.

Athletics Release

I hereby acknowledge that playing or practicing soccer is a potentially hazardous activity. I agree that the participant is voluntarily entering and assuming all risks associated with participating in those activities, including but not limited to falls, contacts with other participants, the effects of weather including heat and or humidity, and the conditions of the training grounds and facilities, all risks being understood and appreciated by me. Having read this waiver, and knowing these facts, and in consideration of Prime Soccer Academy Acceptance of this application, I hereby waive and release Prime Soccer Academy and its officers, directors, agents, contractors, employees, instructors, trainers, volunteers, members, representatives and all affiliated and related companies from all claims and liabilities of any kind arising out of the participant involvement in soccer playing, practicing, or training, while registered as a participant and participating in any and all Prime Soccer Academy sanctioned activities, events, practice sessions or social activities at any location (notwithstanding the location where the participant originally registered) (all hereafter collectively referred to as Prime Soccer Academy Activities, including injury, loss or damage which might be caused by the negligence of Prime Soccer Academy The participant acknowledges that he/she is aware of the possible risks, dangers and hazards associated with participation in Prime Soccer Academy's activities, including all manner of injuries resulting in muscular injuries and soft tissue injuries including bruises, scrapes, cuts, etc., from executing strenuous and demanding physical techniques, collisions with the wall, floor, ground contact with other participants or equipment used by other participants (including ropes, weights and pads) and failure in proper use of the equipment or techniques either by the participant or other participants; and the possible risk of severe or fatal injury to the participant or others. The participant acknowledges that the participant risk of injury increases as the participant becomes fatigued. The participant further acknowledges that such risks may be caused by the participant own actions or

inactions, the action or inactions of others participating in Prime Soccer Academy activities, the condition in which the Prime Soccer Academy activities take place, or the negligence of Prime Soccer Academy. The participant acknowledges that there may be other risks and social and economic losses either not known to the participant or not reasonably foreseeable at this time.

Travel Release

I acknowledge that certain Prime Soccer Academy Activities may take place at a location or locations other than Prime Soccer Academy premises. I further acknowledge that: (i) during outdoor trips to other locations, extreme changes in weather or temperatures may result in heatstroke, sunstroke, or hypothermia and where applicable remoteness of location can result in poor communications and inability to get rescue or medical assistance quickly or easily; (ii) in an unfamiliar location, the participant may become lost, get off course or be separated from the rest of the party; (iii) steep or other dangerous terrains may exist where a fall or other accident may cause injury or death; (iv) risks, injuries and/or death that may result from transportation (all modes or types including but not limited to public or private motor vehicle) incidents/accidents; and (v) Prime Soccer Academy shall not be responsible for any damages or injury caused by or related to the participation of the undersigned or the undersigned minor child (children) in any Prime Soccer Academy activity at such location. If a parent(s) of a minor child (children) has any concerns about transportation to or from an off-site location or any off-site Prime Soccer Academy activity, such parent shall be permitted to accompany such child (children).

General Release

In consideration of Prime Soccer Academy allowing the participant or the undersigned minor child membership and participation in the Prime Soccer Academy Activities, The undersigned agrees: (i) to waive any and all claims that the undersigned or the participant has or may have in the future against Prime Soccer Academy, its officers, directors, agents, contractors, employees, instructors, trainers, volunteers, members and representatives as a result of the undersigned or minor child membership and/or participation in the Prime Soccer Academy activities; (ii) to release, hold harmless and indemnify Prime Soccer Academy from any and all liability from any loss, damage, injury or expense that the participant may suffer, or that the participant next of kin may suffer as a result of the participant membership and/or participation in the Prime Soccer Academy activities due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers Liability Act (Ontario), on the part of Prime Soccer Academy; and (iii) to release, indemnify and hold harmless any affiliated Prime Soccer Academy's company, partnership or other person affiliated with Prime Soccer Academy including those persons which own property used for Prime Soccer Academy activities (collectively, a Related Third Party), and each of their respective directors, officers, agents, contractors, employees, instructors, trainers, volunteers, members and representatives from any and all claims, demands, actions and costs which might arise out of the participants membership and/or participation in the Prime Soccer Academy activities, even though such claims, demands, actions, and costs may have been caused by the negligence of such Related Third Party).

No Representation of Medical Qualifications

I confirm that I have been advised that Prime Soccer Academy does not represent that any employees or contractors have any level of medical training that would provide assistance to an injured person. Moreover, Prime Soccer Academy does not maintain medical equipment or apparatus (including but not limited to defibrillators or Epi-pens) which could assist an injured or ill person. In the event that Prime Soccer Academy is provided with any medical apparatus by or on behalf of a participant in Prime Soccer Academy's activities, Prime Soccer Academy makes no representation or warranty that any Prime Soccer Academy staff or personnel have the skill or training to operate such medical apparatus appropriately to assist any person or to prevent further injury. I acknowledge that I am solely responsible to select and purchase adequate medical/health and travel insurance. No medical/health or travel insurance will be provided by Prime Soccer Academy. In the event of a medical/health or travel related problem, Prime Soccer Academy accepts no responsibility for any costs or damages associated with a medical/health or travel related problem nor will Prime Soccer Academy pay for any medical/health or travel-related expenses, which may be incurred by my participation in the Prime Soccer Academy activities.

Photography and Media

I hereby authorize Prime Soccer Academy to allow the reproduction, dissemination, and/or publication of my name and/or likeness (or those of my minor child) for media coverage, public relations, advertising, marketing or any other Prime Soccer Academy promotional or educational purposes. This may be done in conjunction with my participation in any Prime Soccer Academy activity and I understand and agree that I may neither pay a fee to receive individual promotional consideration from my participation in the Prime Soccer Academy activities nor will I receive any payment for the possible commercial use of my name or likeness.

Liabilities

We assume no responsibility for any personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be occasioned either by reason (1) any act or omission of any of the Suppliers (2) any matter beyond our exclusive control including but not limited to a delay or cancellation of a flight that causes you to miss any portion of the Prime Soccer Academy. We have no special knowledge regarding the financial condition of the Suppliers, unsafe conditions, health hazards, weather hazards, or climate extremes at the locations. We may exclude you from participating in all or any part of the Prime Soccer Academy if, in our sole discretion, your condition or behavior renders you unfit for the Prime Soccer Academy or unfit for continuation once the Prime Soccer Academy has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of Prime Soccer Academy's services, or may constitute a hazard or embarrassment. In such a case, our liability shall be strictly limited to a refund of the recoverable cost of any unused portion of the Prime Soccer Academy. Should you decide not to participate in certain parts of the Prime Soccer Academy or use certain goods included in the Prime Soccer Academy, no refunds will be made for those unused parts of the Prime Soccer Academy or goods. You agree to indemnify and hold us harmless from and against any costs, damages, losses, or liabilities arising out of your actions or omissions.

General

Any dispute related to Prime Soccer Academy shall be governed by Ontario law without regard to conflict of laws principles. The federal or provincial courts in Toronto, Ontario shall be the exclusive forum for any lawsuit related to Prime Soccer Academy, and you consent to the personal jurisdiction by said courts. You agree to present any claims against us within 30 days after the Prime Soccer Academy session ends and to file within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. Facsimile transmission or electronic transmission (such as pdf) of any signed document shall be deemed delivery of an original. At our request, you shall promptly provide an original document as well. If there are any conflicts between this Participant Agreement, the Reservation Form, and the Itinerary, this Participant Agreement shall govern.

Special Provisions for Parents or Guardians of Participants

I, the undersigned, as a parent or guardian, give my consent for the participant, identified herein, to participate in soccer activities during the camp program. I understand that participation in any soccer event is done at our own risk. I will not hold Prime Soccer Academy, its officers, agents, employees, or anyone acting in its behalf, responsible or liable for injury occurring to the named participant in the course of such activities or such travel.

I understand that Prime Soccer Academy will complete required accident insurance forms, after which all claims under insurance policy, or policies, for injuries received while participating in the program activities and events, shall be processed by the participant, his/her parent(s), or guardian(s) through the company handling the participant's insurance claim and not through Prime Soccer Academy.

I hereby accept financial responsibility for personal items lost by the participant identified herein.

I authorize Prime Soccer Academy to transport and to obtain, through a physician of its own choice, any emergency medical care that may become reasonably necessary for the participant in the course of such activities/events or such travel. I also agree that the expenses for such transportation and treatment shall not be borne by Prime Soccer Academy I accept full responsibility and hereby grant permission for the participant to join Prime Soccer Academy.
